Part A - Disclosable Pecuniary Interests

These declarations includes the member's spouse, civil partner, or someone they are living with as husband, wife or civil partner.

(c) Contracts *

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

(If you or your partner have any contracts with Gilberdyke Parish Council or you are an owner or part owner of a business that has such contracts you must declare this here. If the contract is completed and there are no more services or payments arising you do not need to include it.)

(d) Land *

Any beneficial interest in land which is within the area of the relevant authority.

(This is where you must declare any property that you or your partner own in the administrative area of Gilberdyke Parish. If land is held on trust for either of you it should be included in the declaration. It includes both freehold and leased land, including your home if you are a home owner.)

(e) Licences *

Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.

(This is where you must declare any property in the administrative area of Gilberdyke Parish that you or your partner occupy or have the use of, with the permission of someone else.)

(f) Corporate tenancies *

Any tenancy where (a) the landlord is the relevant authority; and (b) the tenant is a body in which the member and/or their partner have a beneficial interest.

(You must declare any properties which you or your partner rent from Gilberdyke Parish Council, or which is rented by a business which you or they own or partly own.)

(g) Securities *

Any beneficial interest in securities of a body where (a) that body has a place of business or land in the area of the relevant authority; and (b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the member and/or their partner have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

(This is about shares, bonds and similar. Only a business that has a place of business or land in the administrative area of Gilberdyke Parish Council is relevant. You must include your partner's interests. Only share ownership that has a face value equal to or more than £25,000 (not the trading value) is relevant, unless you hold 1% or more of the total shares issued or of any class of shares.)
