7.DATA PROTECTION – XX XXXXXXXX

Further to XX XXXXXXXX's request to have his name removed from the parish council minutes and website. Having sought legal advice the Clerk to respond to XX XXXXXXXX confirming that:

- It is the duty of the Clerk to report information sent to the parish council by another public body (in this case the ERY Council) and to minute any relevant information informing decisions taken at council and committee meetings. Once approved it is the Clerk's duty to publish minutes on the council's website. What has been published on the website is already in the public domain.
- The Clerk is the Data Controller in respect of all information held by Gilberdyke Parish Council.
- As Data Controller the Clerk did not consider the reporting or publishing of any information contained in the Decision Notice issued by ERYC contravened the Data Protection Act 1998 given the clear statement in for example para. 5.1 relating to the identity of both Councillor Norris and the complainant (XX XXXXXXXX) and the fact that the Act exempts information required to be published by law.
- Once the minutes are approved and adopted by the parish council it is the parish council's wish, and therefore, The Clerks duty to publish these on the website (and any other method used). Parish Council minutes, once approved, are by law publicly available for inspection by electors, admissible as evidence in legal proceedings and any attempt to prevent or restrict inspection or the taking of copies is an offence (Local Government Act 1972, section 228). An increasing number of local councils now publish minutes of their meetings on council or community website sites and this practice is recommended by both the National Association of Local Councils and the Society of Local Council Clerks under the Freedom of Information Act and in the spirit of openness and public accountability supported by the Government.
- If approved minutes are subsequently found to be incorrect any errors can be further reported to the parish council or appropriate committee, and, if members who were present agree, corrected and published in the same way.

The members present all confirmed that no politics are brought to the parish council meetings. All interests are declared. Agreed for the Clerk to request Mike XXXXXXX clarifies his statements as to whether or not the remark was made against Gilberdyke Parish Council – if not then the remark should be removed and a written apology given to the parish council. Mr P Robinson abstained.

11. FLOOD PREVENTION

11.1 A colour photograph was presented of the illegally piped dyke – rear of Scalby Lane and Chestnut Drive clearly showing a second attempt by a member of the public at potting the dyke incorrectly and illegally. Noted by the parish council.

11.2 Received -

- A second leaflet distributed by Mr M ****** to residents of the village. Noted that parish councillors had deliberately not had a leaflet delivered to their homes.
- Copy of response to previous circular by Mr M ****** which had been sent to certain residents.

It was agreed that both circulars are incorrect and both give the wrong information to residents. The parish council re-iterated the process for the finances of the flood prevention scheme, how qualified independent engineers were used, how the Lower Ouse Internal Drainage Board and the East Riding of Yorkshire Council are taking the lead in the implementation of the scheme, how the parish council has been completely open and above board and how the parish council kept the residents informed and aware of the scheme and all its implications.

11. FLOOD PREVENTION contd.....

The funding for the £80,000 loan has been approved and the scheme will commence as soon as possible.

The parish council is concerned that the information given out by Mr M ****** could be considered sabotage and that anything said and done by the parish is turned to his own incorrect interpretation. It is believed by the parish council that Mr M ****** does not, or chooses not to, understand the process and is working to discredit the parish council to his own benefit.

£50,000 held by the parish council is for the Memorial Hall new build project and will be used as match funding to raise more finances for the new hall. This money is being held in a reserve account and will be placed – following the investigations by the Clerk – in another account especially for the new hall.

The parish council believes Mr M ******* is out of step with the community and his conflicts of interests (not revealed in his circulars) discredit everything he has written and put out into the village.

The benefits of the new flood prevention scheme to the whole community greatly out-way the member of the public with his other agenda and personal interests.

The parish council agreed to place £50,000 in a second reserve account titled Gilberdyke Parish Council Memorial Hall New Build Fund.

The parish council agreed to put £500.00 aside to cover the cost of administration by Mason Clark Associates for the drainage scheme work – this amount held within the £80,000 loan.

The loan approval has been received from the Public Works Loan Board.

The parish council and the engineers will look at ways to have the piped section of Scalby Lane dyke extended – perhaps a further 20 meters if the costs and calculations allow.

The parish council re-affirmed its commitment to ensure the flood prevention work is carried out for the good of the residents and the parish.

12. REPORTS

12.1 Training – the Clerk gave a short report on the Charitable Trust training day. Some work will have to be carried out before any final decisions are made regarding changing the governing document of the Gilberdyke Poor Widows Charity.

WWYC - the last module will be planning in July.
