9.FLOOD PREVENTION

Phase 1. Mr P Robinson confirmed that the work has been stopped and the responsibility lies entirely with Mr N Whitley rescinding written permission for access: this stoppage has nothing to do with either ERY Council, LOID Board or the parish council nor any access concerns regarding 1 Scalby Lane. The contractors have left the site.

Regarding access on 1 Scalby Lane it is believed by the parish council that this was caused by lack of communication between the contractor and the LOID Board with the resident. All problems have either been and or will be resolved.

Regarding the rescinded written permission – legal action will be taken: notice of 7 days will be given and if still objecting there is a risk of conviction and/or fine of £2,500 which would mean a criminal record because it will be a criminal act.

The Clerk to confirm with the Public Works Loan Board that the loan is still available and approved.

Phase 2. Mr P Robinson reported that there are some access issues still be to resolved on Westbrook Road. ERY Council has still to visit all residents concerned with Phases 2 and 3.

The parish council to issue a press release with the intention of keeping the residents and associated interested parties up to date.

- The parish council notes residents continued concerns regarding levels and claims that the system will not work when the full system is commissioned the fall from Westbrook will correct flow with the tides and the flap valve
- There are plans for a further drainage system which involve a pumping station at Blacktoft taking drainage water out into the river when complete more water will be removed from Gilberdyke and surrounding area
- Scalby Lane Dyke is owned by HORNCASTLES. Properties on Scalby Lane and Chestnut Drive with a boundary to the newly developed dyke stop all boundaries stop at the top of the dyke banking
- The parish council is concerned that some residents have already, even before the phase 1 is completed, land-grabbed areas of land which is definitely not theirs to claim. This practice has to stop. Access has to be readily available for maintenance
- Future maintenance of the system the parish council has agreed to place in budget an annual amount to cover cost of clearing and cleaning and will approach HORNCASTLES with a view to discussing further the future security and maintenance of the dyke
- The options for the future maintenance of the dyke are varied and will involve the LOID Board, ERYC, HORNCASTLES, the parish council and residents but the area has to be left clear with no hard landscaping, buildings, planting or interference of any sort

The parish council resolved to approach HORNCASTLES to arrange a meeting and to be prepared to take advice from solicitors at all times. The Clerk to contact HORNCASTLES and arrange the meeting.

The work on the next project – the pumping station at Blacktoft – will be a further 2-3 years before complete.

Proposed for the residents of Westbrook and the parish council to convene a meeting to discuss the project.

A request from Ms D Mansell for the replacement of plants removed or damaged by the phase 1 work was received and discussed. All requests for compensation to be considered when phase 1 has been completed. The Clerk to contact Ms D Mansell.

9.PLAY/RECREATION – deferred to September 2011 meeting.

10.1 Jubilee Pond– Lifestyle group – The Chairman I working with a group of youngsters with the intention to place bird boxes at the pond.
