## 7.REPORTS

## 7.1 Play Area

The lease is still outstanding but the Title Deed needs to be found for the solicitor so the lease can be drafted for consultation.

It was resolved to work on the lease as it is imperative for funding of the play area.

Cleaning of the play area to be a separate agreement – deferred to an appropriate parish council meeting.

## 7.2 G D L A

Mr A Wilson reported – there had been no meeting recently but there is a scheme by the F.A. and a mobile phone company. The F.A., in conjunction with the phone company, would agree to donate £40,000 (for flood lighting) over 10 years in exchange for the erection of a mobile phone mast.

## 7.REPORTS contd.....

The parish council confirmed that the Ings View sports field is actually the parish council property and, therefore, the £40,000 should come to the parish council not the G D L A.

It was resolved for the information regarding this proposal to be forwarded to the parish council for discussion as an agenda item at the February parish council meeting.

Hedge – quotes are being sought for cutting the hedge.

## 7.3 Memorial Hall

Mr J Jessop reported that letters of support need to be sent to GROUNDWORK for the grant applications from the parish council.(Play Area).

Also letters of support to accompany the funding applications for a replacement flat roof.

Mr J Mansell confirmed his resignation of Treasurer to the War Memorial Hall Committee.

Mr J Jessop also reported that NPOWER are overcharging on vat – the committee is currently negotiating with the HMRC but the committee will also be looking at group funding for fuel in the future.

## 7.4 Jubilee Pond – no report

<u>7.5 Parish Paths</u> – resolved for the Clerk to repeat request regarding possible fly-tipping of rubbish Thornton Dam Lane – north and possible fly-tipping in and around the landfill site.

7.6 Highways – resolved for the Clerk to report potholes around the parish.

#### 7.7 Flood prevention

Mr P Robinson remarked that the work the parish council undertook for phase 1 and the work undertaken by the ERY Council for phases 2/3 has quite clearly worked as intended. It is very re-assuring to see water come into the village and leave without causing any flooding. Although there were some doubting Thomas', who held the flood work up so that costs were increased and timescale for the work lengthened, all obstacles were overcome. Should there ever be rain as catastrophic as before then perhaps the village will not get the flooding, damage and upset as in 2007. The recent heavy rains did not cause any problems mainly because the work did get done. Insurance costs for residents have been reduced and it is believed the parish council will continue to apply pressure for the proposed pumping station scheme.
