The Chair opened the meeting.

1. To agree: Apologies received

Councillor Paul Bryan (domestic emergency), Councillor Nick Norris (holiday), Councillor Jeannie Peachey (ill health). All apologies were agreed.

2. Declarations of interest

Councillor Taylor-Dunn advised that she had a personal interest relating to item 16 on the agenda.

c) Update by Cost Centre

i) Administration

With effect from 3 July 2023, the Clerk's office hours will be Monday to Friday, except Bank and Public Holidays.

ii) Services

The Youth Project have applied for grant funding from the National Lottery.

iii) Income

The Youth Project have received £500 from the Tesco community grants scheme.

iv) Projects

I will be seeking a solicitor to handle the lease of the area for a storage unit at GWMH shortly.

v) Grants

The Parish Council's grant application process will be online by preference. The online form is undergoing final testing and should be ready to roll out in July.

11. To agree: Financial Report

12. To agree: Christmas Working Group

- a) Christmas Working Group Terms of Reference.
- b) That the first meeting be held at 7:00 pm on Tuesday 18 July, in the Conference Room of Gilberdyke War Memorial Hall.
- c) That, at its first meeting, the Christmas Working Group should establish the budget the Working Group believes is required for 2023 and submit a recommendation to the August Parish Council meeting.

This was agreed unanimously.



13. To agree: Recommendations from Services Committee meeting held on 7 June 2023

- a) That the Parish Council agree that the following areas should be submitted to the Community Payback team for consideration:
 - The footpath from Thornton Dam Lane to the White Horse public house on the north side of B1230
 - The area behind Flaxmill Walk nearest the railway line
 - The garages behind the shops on Willow Green

This was agreed unanimously.

b) That the Parish Council agree that the Clerk should canvass councillors to suggest private hedges that required attention by their owners, which could then be referred to East Riding of Yorkshire Council for enforcement action.

This was agreed unanimously.

c) That the Parish Council limit the issue of further fishing permits to those whose address is within Gilberdyke parish, with immediate effect.

Councillor Buckle proposed an amendment to include a review date of 6 December 2023 (that being the date of a scheduled Services Committee meeting), which was seconded by Councillor Woolass and agreed unanimously. The recommendation was then amended to:

"That the Parish Council limit the issue of further fishing permits to those whose address is within Gilberdyke parish, with immediate effect, and that this decision is reviewed on 6 December 2023."

This was proposed by Councillor Buckle, seconded by Councillor Woolass and agreed unanimously.

14. To consider: Planning Application 23/01189/PLF, Erection of a single storey rear and garage extension, Fiddleneck Lodge, Main Road, Scalby, East Riding of Yorkshire, HU15 2UU.

The Parish Council agreed that it had no comment to make upon this application.

15. To resolve: That the Parish Council resolves to exclude members of the public and press (except the appellant) from the meeting for agenda item 16 as the individual concerned would be identified during the item.

This was proposed by Councillor Buckle, seconded by Councillor Taylor-Dunn and agreed unanimously.

16. To consider: Appeal against ban on fishing

The Parish Council agreed to partially uphold the appeal and revised the penalty to:

- That a letter of apology be sent by the individual concerned, via the Clerk, to the bailiff
- That the individual concerned is accompanied when fishing at all times until reaching their 12th birthday
- 17. To note: Time, date and location of the next Parish Council meeting. This will be held at 7:00 pm on Monday 10 July 2023, in the Conference Room of Gilberdyke War Memorial Hall.
